The scientific fields of interests: From the beginning of the 20-year professional career, Joanna Kurowska-Pysz combines academic activity with practice in the consulting industry. She is a recognized manager running international projects and an evaluator of international EU programs known as INTERREG. She is also an owner of spin-off company KREATUS Ltd in Bielsko-Biała developing studies and projects for local authorities, entrepreneurs, nongovernment organizations as well as public and private institutions.

Since 2013, Joanna Kurowska-Pysz, has been a teaching and research worker at the Faculty of Applied Sciences of the WSB University in Dąbrowa Górnicza, where she also holds a function of the Director of Technology Transfer Centre and The Director of Research Institute on Territorial and Inter-Organizational Cooperation.

Areas of scientific interest of Joanna Kurowska-Pysz include: inter-organizational cooperation, territorial governance, public project management and revitalization, new educational models of competencies development.

The intersection of these research areas led Joanna Kurowska-Pysz to create a unique, research institute focusing on territorial and inter-organizational cooperation. These studies are conducted mainly in the social, economic, technological and environmental context. Importance and significance of the research have been recognized by the Ministry of Science and Higher Education, which granted subsidy for establishing the Institute on Territorial and Inter-Organizational Cooperation at the WSB University, as a part of 4-year development program known as the "Regional Initiative of Excellence" addressed to the best Polish regional universities. The institute, created by Joanna Kurowska-Pysz, PhD, operates under the auspices of Jaroslaw Gowin, PhD, the Deputy Prime Minister of Science and Higher Education and Jadwiga Emilewicz the Minister of Entrepreneurship and Technology.

The development of the research institute on territorial and inter-organizational cooperation, as well as the establishment of the Research Institute on Territorial and Inter-Organizational is a response to the needs of many different groups of stakeholder identified by Joanna Kurowska-Pysz. These include: local and regional authorities, non-government organizations, public and commerce institutions, clusters and networks.

In the years 2001-2019, Joanna Kurowska-Pysz participated in the development of many local strategies and plans, among which were: 14 revitalizations plans for such towns as: Cieszyn, Żywiec, Pyskowice, Sułkowice, Szczyrk, Brzeszcze, Baranów Sandomierski, Sośnicowice, Kalety, Lelów, Czernichów, Świnna, Mszana, Dąbrowa Górnicza. Social participation methods used by Joanna Kurowska-Pysz to develop the strategies were: debates, research walkings, Charette workshops, future city games, public speeches, World Café methods.

Joanna Kurowska-Pysz is certificated in the field of revitalization by Polish Ministry of Regional Development. She also developed almost 30 cross-border projects focusing on practical and research problems related to the territorial cooperation, primarily in the field of education, science, culture, tourism and entrepreneurship. A considerable part of these projects has also been personally implemented by her.

She also graduated a course at Aalborg University in the field of Problem Based Learning . She adopted this method and uses it in practice and teaches students according to PBL as a part of the project management course.

Professor Joanna Kurowska-Pysz applies her theoretical knowledge and application experience regarding the cross-border cooperation issues, both in scientific and expert activities, which she runs for the Ministry of Investment and Development of the Republic of Poland, the Ministry of Development of the Czech Republic and the Ministry of Agriculture and Rural Development of Slovakia - as the managing authorities and national institutions responsible for implementing the INTERREG program. As a member of teams responsible for evaluation of cross-border cooperation programs, she conducted international research in Poland, Czech Republic, Slovakia, Germany, Denmark, Sweden and Lithuania. In 2019 she worked as an expert of DG REGIO, European Commission, responsible for the research regarding the Polish-Lithuanian cross-border cooperation plan in micro-scale.

Professor Joanna Kurowska-Pysz is, among others, a member of two international research groups: Valoriza at the Politechnic Institute of Portalegre (Portugal) and ARAM at the University of Extremadura (Spain), a member of the Polish Academy of Sciences (Commission for Polish-Czech and Polish-Slovak Relations) and a member of the Scientific Society of Organization and Management (Vice-President of the Board of Directors TNOiK in Dąbrowa Górnicza). The author also cooperates with international integration organizations, eg. Academia Europa Nostra, euroregions and European groupings of territorial cooperation. She participated in 30 national and international scientific conferences, at which she presented scientific papers.

She is a member of the editorial board of magazines: Revista Estudos de Planejamento, (ISSN 2595-9018) and Cultural Management, Science and Education (ISSN 2512-6962, indexed in Scopus). She also reviews scientific publications in the following magazines: Polish Journal of Management Studies, Sustainability, Entrepreneurship & Regional Development, Sustainable cities and society, Journal of Open Innovation: Technology, Market & Complexity, Social Sciences, Forum Scientiae Oeconomia, Cultural Management: Science and Education.

Professor Joanna Kurowska-Pysz is a Committee Member in the COST Action project: ENTAN - European Non-Territorial Autonomy Network (2019-2022), financed from the Horizon 2020 program. She works also in this project as a member of Science Communication Group and as a member of the research group: Regional and socio-economic development: incentives and resources. In this international research project Professor Joanna Kurowska-Pysz deals with issues of cross-sector cooperation (state, local government, enterprises, non-governmental organizations, scientific units, media), taking into account the processes of social participation in managing the development of these areas. She cooperates with many universities such as universities in: Ostrava, Liberec, Olomouc (Czechia), Żylina, Banska Bystrica and Liptovsky Mikulas (Slovakia), Extremadura (Spain), Portalegre and Madeira (Portugal), LISER (Luxembourg), South Denmark (Denmark), Kaliningrad (Russia), Rio Grande do Sul (Brasil) and FISAT (Peru).
